# The Morris Area Foundation Financial Statement as at Dec 31, 2014

As at Dec 31, 2014 we had \$8634.65 in our Bank.

This has been separated into 2 accounts-

Endowment fund - which has \$6440.00- this is comprised of all the community donations plus any "grants" from other foundations such as the Winnipeg Foundation and Thomas Sill Foundation and will become an invested fund. Annual community grants will come from this fund. Administrative fund -which has \$2195.65- this is comprised of the monies received from the Lions Club and any administrative grants that foundations give us for administration. Example- the Thomas Sill Foundation is giving us \$1000.00 for administrative expenses if we reach the minimum requirement for their "Challenge". The Winnipeg Foundation gave us \$200.00 to cover the conference fee for a workshop that Del and I attended.

Page 2 is the recap of our revenues and expenses for 2013 and 2014. We are very pleased to say that in 2015 we have already received another \$12,000.00.

# THE MORRIS AREA FOUNDATION INC. – Activity Report June 4, 2015

The Morris Area Foundation includes "the Rural Municipality of Morris, the Town of Morris and the other communities of the R.M., Aubigny, Lowe Farm, Rosenort and Sperling.

At the end of December 2012, just over \$3,000 which had been set aside by the Morris Lions Club when it dissolved, was turned over to the Foundation to advance its cause.

The Morris Area Foundation Inc.'s charitable status was finally granted effective January 1<sup>st</sup>, 2013. A lot of work went in over the years previous to get to this point by some current board members, staff of the R.M., Town and others.

The Morris Area Foundation joined the Community Foundations of Canada for 2014. This opened a whole network of assistance, encouragement and connections.

Also in 2014 a brochure was developed. In September, Midge and Del attended a Manitoba Community Foundation Conference in Selkirk. They learned how the other almost 50 foundations operated in Manitoba. It was here that we learned about the Endow Manitoba Campaign and the 24 hour challenge held in November. "Through the Endow Manitoba website donations were made on line by credit card. The Winnipeg Foundation covered the credit card fees." The result was \$4,950 in donations which was stretched by another \$990 by the Winnipeg Foundation for our **unrestricted community endowment fund**. We are anticipating a similar 2015 "Program".

The Board has developed: The Granting Program Policy and Procedures, the Spending Policy for the Foundation and the Grant Application form. Other operational Policies will be developed in the near future. We are aiming for an October 2, 2015 intake for community grant applications.

Recently, the Thomas Sill Foundation announced a "Giving Challenge" available to Manitoba Community Foundations. We applied and as a result signed an agreement with them in March 2015. Over the 18 months of the "Challenge" The Morris Area Foundation undertakes to raise at least \$10,000 to a maximum of \$50,000 which will be matched on a 1:2 ratio (if we raise \$50,000 the Thomas Sill Foundation will contribute \$25,000). We

were required to submit a strategic plan detailing how we were going to get there! We are well on the way with the minimum already raised. The Thomas Sill Foundation has also contributed \$1,000 for administration expenses like: promotion.

We are activity seeking representation to the Board from the areas of Rosenort, Aubigny and the rural portions of the RM. We need you to make this a success down the road.
