Ways to Donate

Publicly listed securities

To get an added tax advantage, you may donate securities listed on specific stock exchanges, mutual funds and segregated funds instead of cash. Under a recent change to the Income Tax Act, the effective taxable capital gain from the disposal of the security will be zero instead of one-half.

Bequests of life insurance or registered plans

You can donate the proceeds upon death from a life insurance policy, RRSP, RRIF or TFSA by naming the charity as the beneficiary, or by naming the estate as the beneficiary and naming the charity in the will to receive the proceeds. Such charitable gifts are treated as if they were made in the year of your death and are eligible in determining the charitable donation tax credit on your final tax return or the immediately preceding return.



CHAIR'S REPORT

Together we can improve our communities. We can make a difference!

Despite another year of Covid disruption, the Morris Area Foundation (MAF) has again made significant progress.

The Endow Manitoba Giving Challenge held in November has broken MAF's previous records, with both the number of donors and the amount of monetary gifts. Raising over \$41,000, MAF's general community endowment fund has grown to just over half million dollars thanks to the generous support received.

The Foundation's new accounting system is now in place thanks to the support of Endow Manitoba. We much appreciate the new laptop and software as well as set up and training provided by the Endow Manitoba team.

Recognizing the need to build a fund, wherein the interest earned will help to cover the expenses of operating a growing community foundation, has prompted the Board to start a new Admin Support Endowment Fund. Income from this fund will be used to assist with MAF administration costs.

We greatly appreciate the support we

have and continue to receive from Endow Manitoba, both financially as well as advice and assistance with board and accounting responsibilities.

This coming year we plan on expanding the board with more diversification in age and geography. Board training is planned in the fall of 2022 for new as well as current members.

The work of a community foundation is ever evolving. However, the work of a community foundation is also here forever. Growth does not happen all at once but is driven by small steps as the MAF board strives to become a trusted, reliable, and predictable source of funding to assist in meeting community needs.

If you do not have a lot to give financially, volunteering can be just as valuable as a monetary gift. Volunteers are needed to create awareness of the Foundation, serve as board or committee members, and carry on MAF's day-to-day operations.

THE MAF HAS SUPPORTED A WIDE VARIETY OF PROJECTS

2021 Morris Area Foundation Grant Committee Report

After a very busy 2020 which included grants through the Emergency Community Support Fund and the Build 150 Program, 2021 settled into a more normal granting program. In total for 2021, the MAF was able to support 8 projects for a total of \$13,500.

This year grants were awarded to:



(1) Morris Community Gardens - \$1,500 for the Replacement and Upgrade of Raised Garden Boxes. MAF Shelley Stupnisky and Midge Anderson presented Pat Rempel chair of the Morris Community Gardens project with a cheque for \$1,500 to assist in the replacement and upgrade of 6 raised garden boxes.



(2) Morris & District Centennial Museum Inc. - \$1,000 for the purchase of the Museum Collections Management Software. This Manitoba Museum designed software will provide greater fields for descriptions and locations in the Museum and will allow the public access to databases in the future.



(3) Habitat for Humanity Manitoba – MAF Director Dennis Matthies and Curtis Evenson (Vice-chair) present to Habitat for Humanity Manitoba board member Mike Palitsky in support of the Rosenort "Home Build" project.



(4) HEART Team Inc. — MAF Shelley Stupnisky (Secretary) and Curtis Evenson (Vice-chair) present a \$2,000 cheque to Paul Maendel and Manuel Maendel of the HEART Team Inc. in support of the "Water Rescue Hovercraft Purchase".



Cash Donation

This is the simplest type of donation. But before dropping that cheque in the mail, you may wish to consider alternative giving strategies that can increase the benefits of the donation for you, your charity, and your estate.

Donate Online

Online donations are processed without charge by The Winnipeg Foundation through the Endow Manitoba website. https://www.endowmanit oba.ca/make-a-gift/ Select the Morden Area Foundation, and follow the prompts.

Gifts in Kind

These are donations of property including artwork, securities and real estate. Tax credits for 'gifts in kind' donations are determined by the fair market value of the gift at the time of the donation. However, you must also report any resulting capital gain or loss on the disposition of that property.

Ways to Donate

Charitable Remainder Trusts

You make a gift to a charity during your lifetime yet continue to receive the income generated by the investments. Through an irrevocable inter vivo trust (known as a Charitable Remainder Trust), the charity you name is established as the capital beneficiary. However, the capital is not accessible to the charity during your lifetime. All interest and dividends earned by the trust are paid to you as taxable income. You receive a charitable receipt equal to the present value of the capital which the charity is expected to receive at the time of your death. The donation is removed from your estate and would not be subject to probate fees or claims by creditors.

ENDOW MANITOBA GIVING CHALLENGE



November 15 – 21 Endow MB Giving Challenge week. The Morris Area Foundation (MAF) raised a total of \$41,395.20. Congratulations!

This challenge is an opportunity offered by Endow Manitoba that upon raising \$10,000, Endow MB will match funds by \$2,000 plus the Government of Manitoba will match funds bv \$2,000. PLUS MAF received further matching funds from the following generous organizations: Lowe Farm Credit Union - \$2,000, Morris Credit Union - \$2,000, Rempel Insurance -\$2,000, Bigway - \$2,205.20. A \$10,000 challenge quickly became \$22,2025.20 investment in the MAF community. Who doesn't get excited by an opportunity like that?

The annual Bigway "Round Up" was a huge success again this year too. During the 10-day event held in November, Bigway staff at the tills invited customers to "round up" their purchases to the next dollar with the change gifted to MAF. Morris Bigway generously matched the gifts received at the till, resulting in \$2,205.20 raised toward the Morris Area Foundation General Community Fund.

Legacy gifts to the Morris Area Foundation can be directed to an existing fund, or you can create your own endowment fund.

What is an endowment fund? An endowment fund is like an investment account for our community. Gifts are permanently invested and a portion of the income earned (the spending policy) is distributed every year to local registered charities as grants.

Why make a legacy gift to the Morris Area Foundation? There are a lot of great reasons. You can...

- Support a cause you care about.

Since endowment funds are permanent, you will help our community For Good. Forever.

How to make a legacy gift to the Morris Area Foundation. The most common legacy gift is a charitable gift through a Will (bequest).

We are here to help you make sure that your gift supports what you care about...because we care about it too!

We will document your instructions carefully to ensure that we use your gift as you intend. You or your lawyer may also wish to have us review any Will wording naming the Morris Area Foundation to ensure we fully understand your wishes and to confirm that we can administer your gift as you prefer. It is essential to remember to provide the lawyer drawing up your Will with the correct name and charitable registration of any organizations named in your Will. The Morris Area Foundation's charitable registration number is 88029 6413 RR0001.

Tax Benefits of All Bequests. Charitable bequests provide for your favorite cause with the potential of greatly reducing taxes owing and helping preserve the value of your estate.
