Publicly listed securities
To get an added tax
advantage, you may
donate securities listed
on specific stock
exchanges, mutual funds
and segregated funds
instead of cash. Under a
recent change to the
lncome Tax Act, the
effective taxable capital
gain from the disposal of
the security will be zero
instead of one-half.

Bequests of life insurance or registered plans

You can donate the proceeds upon death from a life insurance policy, RRSP, RRIF or TFSA by naming the charity as the beneficiary, or by naming the estate as the beneficiary and naming the charity in the will to receive the proceeds. The government treats such charitable gifts as if you made them in the year of your death, making them eligible to determine the charitable donation tax credit on your last tax return or the immediately preceding return.

Although the MAF receives gifts throughout the year, The Endow Manitoba Giving Challenge is truly the highlight. Endow Manitoba is the arm of The Winnipeg Foundation that supports the work of the Manitoba community's foundations through research, programming, and grants.

The Giving Challenge is an opportunity offered by Endow Manitoba and local business. Upon raising \$10,000, The Winnipeg Foundation, Manitoba government, and area businesses, Access Credit Union and Rempel Insurance Brokers each contributed \$2,000. That's a great way to boost MAF's General Fund. Who doesn't get excited by an opportunity like that?

For the last several years, Morris Bigway has offered a "Round it Up" event during the Giving Challenge. The Bigway checkout staff invites customers to "round up" to the next dollar for the MAF. Morris Bigway has generously matched this amount. Thank you to Pat and the staff for this support over the many years. In 2023, this event added \$2,265.74 to the Endow Manitoba Challenge.

for 'gifts in kind'

determined by the fair
market value of the gift
at the time of the
donation. However, you
must also report any
resulting capital gain or
loss on the disposition of
that property.

Smith Park Bell Tower Project

On August 2, 2023, they lowered the Lutheran Church of the Cross Bell Tower into position at Smith Park in Morris. The Tower has a long and interesting history.

Rumsey Mfg. made the Anglican Bell in St. Louis Missouri in 1883. According to the Morris Journal (1967), they constructed the All Saints Anglican Church in 1875. However, in the King Solomon Lodge Records, the cornerstone for the All Saints Anglican Church in Morris said to be laid on July 7, 1880. They originally built the Church on the north side of the Morris River, but later moved it to the corner of Main Street and Mulvey Avenue in 1898. People remember that the bell tolled on the day of Queen Victoria's death – January 22, 1901. The Anglican congregation joined with the



Methodists and Presbyterian congregations and the Anglican diocese then sold the building to the Lutheran congregation in 1920. The congregation used this church until the year 1968, and then they tore it down. In 1969, they completed the new church building, but it didn't have a bell tower. Therefore, for the next 10 years, the 400 pound historic brass bell sat idle in the Lutheran Church of the Cross parsonage garage. In 1977, Egon Grossman took charge of organizing the Bell Tower Committee. Over the next two years, the committee spent many hours researching and finding qualified people to complete the project. Mr. Steve Herbst from Winnipeg was the drafter. Mr. Cliff McPherson, the owner of a machine shop in Roseisle, devised an electrical mechanism to ring the bell. Alta Steel of Winnipeg provided the steel. Mr. Milton Kelm and Mr. George Smith of Morris did construction and were in charge of electrical wiring. They erected the tower in the beginning of December 1978 and after 10 years of silence; the bell rang again on Sunday, December 24, 1978. In 2016, the church building had to be sold because of high costs of maintenance and small membership. The Town of



Morris received a donation of the Bell Tower and moved it to Smith Park.

In 2022, the Morris Area Foundation, with the help of the Province of Manitoba Build 150 Program awarded the Lutheran Church of the Cross "Smith Park Bell Tower" project \$750 to assist in the relocation of the bell tower to Smith Park in Morris.

Charitable Remainder Trusts

You make a gift to a charity during your lifetime yet continue to receive the income generated by the investments. Through an irrevocable inter vivo trust (known as a Charitable Remainder Trust), the charity you name is established as the capital beneficiary. However, the capital is not accessible to the charity during your lifetime. You receive all interest and dividends earned by the trust as taxable income. The charity expects to receive the capital at the time of your death, and you receive a charitable receipt equal to its present value. When you remove the donation from your estate, you avoid probate fees or claims by creditors.

The Morris Area Foundation is pleased to announce the Formation of The Mike Hesford Music Fund. When Mike Hesford passed away in 2011, the Access Credit Union in Morris set up a fund in his memory. In early 2023, the Access Credit Union in Morris moved these funds to the Morris Area Foundation.

The Morris Area Foundation establishes the Mike Hesford Music Fund as an endowment fund. The Morris Area Foundation will grant the interest earned on the invested funds annually and in perpetuity to organizations supporting music in our area.

Donations to The Mike Hesford Music Fund are eligible for Tax Donation receipts and are welcome anytime.

Youth in Philanthropy

In 2017, the Youth in Philanthropy (YIP) Morris/Rosenort Schools group began with a three-year supporting grant from the Thomas Sill Foundation. Every year, the groups disbursed \$2500 to community groups within the Morris and Rosenort area following the guidelines of the Morris Area Foundation. The Morris Area Foundation has continued to provide funding for the last three years. The YIP groups contributed to funding for many diverse projects, which are listed below. The grade 7 to 9 students in Rosenort and grade 10 to 12 students in Morris have experienced the impact philanthropy can have on their communities.

Although the Morris/Rosenort Schools YIP program has been concluded it is the hope of the MAF board that there may be a group of students become interested in participating in this program once again.

Grant Committee Report



Principal Mike Watson of the Morris School spoke of a major project at the Morris School involving a complete revamp of the original Senior Years Kitchen. The staff are seeing an increase in demand. He noted that the current area size and equipment limited the current breakfast club and snack programs. Watson envisioned expanding the

The MAF area covers the Town of Morris, the entire RM of Morris—including the communities of Rosenort, Lowe Farm, Aubigny and Sperling. The MAF is happy to receive donations from all these areas and pleased to receive applications and to grant back to projects over the entire area!

Since offering grants in 2015, the MAF through partnerships with Thomas Sill Foundation, Wpg. Fdn., Endow MB., Prov of MB., Community Foundations of Canada area businesses and individuals has returned over \$170,000 to our area.

The Morris Area Foundation held its second annual granting awards celebration on December 5 at the Morris Multiplex.. The foundation was pleased to announce 10 awards totalling \$26,500.

offering at lunch and being able to provide hot food at events served by volunteers, students and staff. Fund raising is underway.

The granting committee allocated a grant of \$10,000 over 2 years to The Morris School for the Senior Years Kitchen Upgrade.

Second guest Janice Graydon, co-chair of the Willow Park Committee in Morris, showed pictures of the very successful and busy completed Phase 1 of the Willow Park re-development.

In 2022, the Willow Park Committee received a grant of \$5,000 from the Morris Area Foundation to assist in the revitalization of the existing Willow Park. The objective being to create a unique and significant

attraction destination park for new events for community members and others from the surrounding area.

On July 13th, 2023, they officially opened the new Phase I of Willow Park. Committee members Janice Graydon and Melissa Lamotte posted the following on Facebook. "This project was inspired by families to be able to engage and play with one another as well as with other families in the community. We are humbled by the excitement, positivity, and gratitude that we have received with our vision becoming a reality." Congratulations to the Willow Park Committee. On to Phase 2!



Graydon also showed plans for Phase 2 development, including a picnic shelter, canteen, storage facilities, BBQ rentals, and two-family washrooms. The committee currently expects Phase 2 to cost approximately \$375,000 when we complete it in 2025. Fund raising is underway.

The Willow Park Committee received \$5,000 over 2 years to go towards the Willow Park Project-Phase 2.

The Morris Community Gardens received \$1,000 to be used to frame the 16 new galvanized steel raised metal beds, as the edges are sharp and could cause injury.

The Valley Agricultural Society-host of the Manitoba Stampede and Rumble in the Valley Tractor Pull received a grant of \$3,000 to be used to help widen the grandstand steps and replacement of handrails on the grandstand.

The Sperling Community Centre received a grant of \$1,300 to assist in the upgrade to new fire alarms and security lights at the Sperling Arena.

The Morris School Band Camp; Music Program received a grant of \$700 to be used for purchasing an upright bass-pickup and additional concert band instrument upgrades.

The Morris Wellness Centre received a grant of \$1,000 from the grant committee to assist in the purchase of a new "Hip Thrust Machine".
